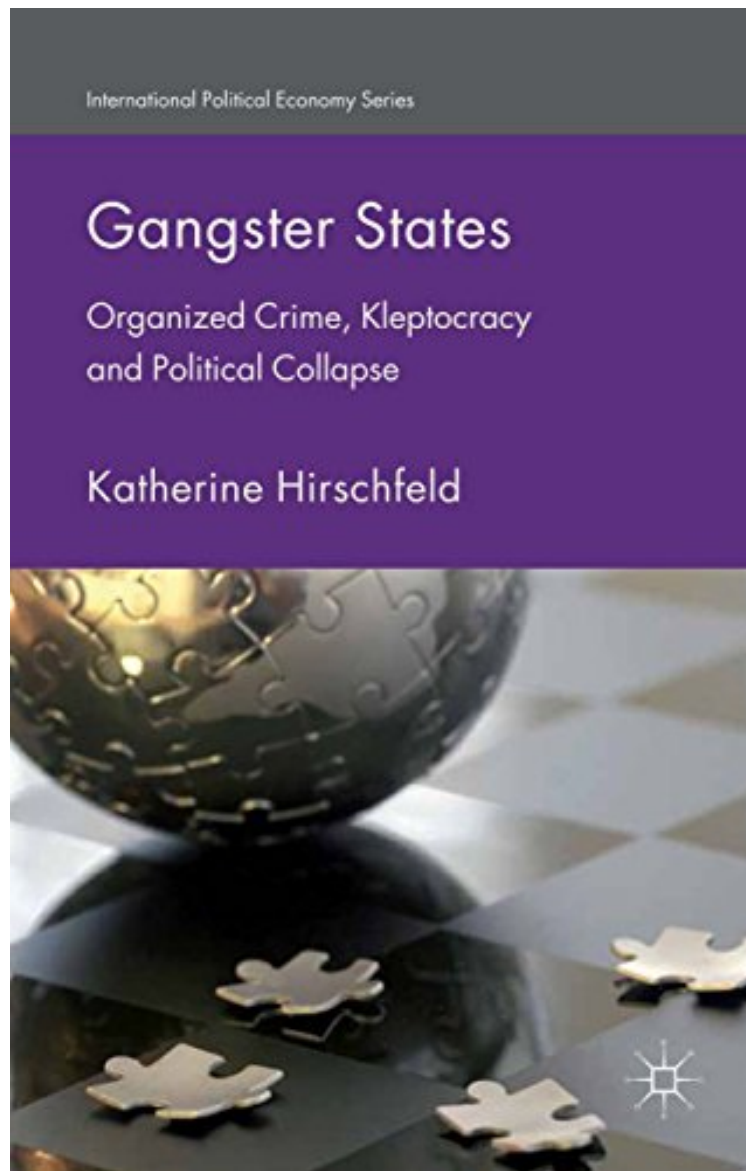

Gangster States is a fascinating book that challenges many widely held assumptions about governance, markets, and organized crime. One of Hirschfeld's most compelling arguments is that there is an evolutionary continuum between organized crime and states. This does not mean that organized crime networks necessarily develop into states, or that all states emerge from racketeering, but under the right conditions this transition may occur. More broadly, Hirschfeld's analysis undermines any simple dichotomy between states and markets. She demonstrates that the two are always intertwined and that markets do not exist without some form of state intervention. Hirschfeld shifts the discussion to consider when and how states intervene and the particular sets of interests that are protected in this process. Through out Gangster States Hirschfeld writes in a clear and compelling voice, and her arguments are supported by a number of interesting case studies from around the globe.
