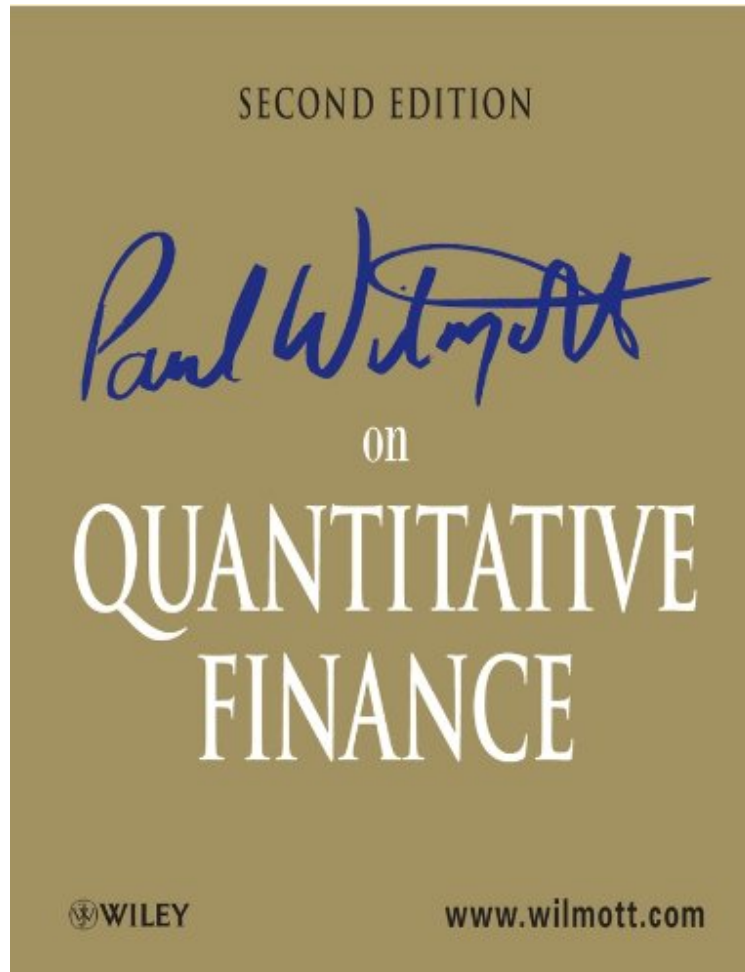

They specify the author and publishing year, but often omit the name of the book (e.g. Wilmott refers to Neftci's 1996 book as the best on stochastic calculus for beginners, yet doesn't show anything by this author from that year)4 of 5 people found the following review helpful.
